## **FLGISA Scholarship Application Packet 2026**

The FLGISA is proud to announce the following FLGISA College Scholarships. A total of \$33,000 is available for the **children of FLGISA member agency employees** who are high school seniors entering college in the fall and currently enrolled undergraduate students. There will be 22 scholarships (\$1,500 each) offered: three in each district, one per the President, and three at the discretion of the FLGISA Executive Board.

***FLGISA District Scholarship (18): Northwest District, Northeast District, Central West District, Central East District, Southwest District, and Southeast District.***

Awarded to the child of an employee in a member agency in the above district regions. The child must be a high school senior or a currently enrolled undergraduate student at an accredited college or university who has exhibited academic excellence and community spirit. This student will be awarded a scholarship toward college expenses to assist their educational experience and growth.

### ***FLGISA President's Scholarship Award (1)***

Awarded by the current FLGISA President to a child of an employee in a member agency in any of the six districts. The child must be a high school senior or a currently enrolled undergraduate student at an accredited college or university who has exhibited academic excellence and community spirit. This student will be awarded a scholarship toward college expenses to assist their educational experience and growth.

### ***FLGISA Executive Board Scholarship Award (3)***

Awarded by the FLGISA Executive Board to the child of an employee in a member agency in any of the six districts. The child must be a high school senior or a currently enrolled undergraduate student at an accredited college or university who has exhibited academic excellence and community spirit. This student will be awarded a scholarship toward college expenses to assist their educational experience and growth.

***NOTE: The selection committee comprises two members from a neighboring district. If there is a conflict of interest, the committee members must excuse themselves if the scholarship application is for a family member (child, stepchild, niece, nephew, or grandchild).***

## **Eligibility:**

Scholarships will be granted to high school seniors or currently enrolled undergraduate students **who are children of employees** working for FLGISA member agencies and attending an accredited college or university. The following minimum criteria must be met:

- U.S. citizen or permanent resident graduating from high school or currently enrolled at an accredited college or university.
- If awarded a scholarship, the student must be enrolled full-time. Proof of enrollment at post-secondary institutions is required to release award funds.
- 3.00 cumulative grade point average, ability, and motivation to compete on a collegiate level.
- Preference will be given to candidates who demonstrate strong educational motivation and group leadership skills through their activities in school, church, youth groups, community volunteer efforts, and/or work experience.
- Financial needs and letters of recommendation are additional criteria in the selection process.
- Previous scholarship recipients may reapply, but new applicants will be given greater consideration.

## **Scholarship Rules:**

- Scholarships will be given for the summer or fall of 2026. In all cases, the awards will be given to the institution and sent directly to the institution's financial aid offices within 30 days of receipt of proof of the student's full—or part-time enrollment at the school.
- If a recipient cannot begin school in the fall and plans to enter school in a future semester, the recipient **must** notify the FLGISA in writing by June 30, 2026, for an extension. An extension is provided for up to one calendar year. If the scholarship is unused by the end of that year, the scholarship is forfeited and will be used to fund another scholarship in subsequent years. It is also forfeited if no extension is requested by June 30, 2026.
- Recipients will be recognized at a time and location to be determined.

***Letters of Recommendation:*** Choose two people to write letters of recommendation for you. It is strongly recommended that one letter comes from a teacher or other school employee and one from an employer or friend (non-family related) who knows you through work or volunteer activities. Please enclose the letters with this application.

***Transcripts of Grades:*** Your application must include high school transcripts and SAT and/or ACT scores. If you have taken any college courses, including a transcript of your work thus far. **If you are an undergraduate, we only need your college transcripts.**

***Student Personal Statement:*** Write a statement (no longer than 500 words) explaining why you are applying for a scholarship, your future plans, and your short and long-term goals. You should also include any other information about yourself, your family and background, your educational achievement, etc., which will help the Scholarship Committee to evaluate your potential.
